ISA National Squad 2008 Acceptance & Agreement

Overview

This Acceptance and Agreement is for all athletes/teams included as members of the 2008 National Squad. National Squad nominees must complete and submit this National Squad Acceptance and Agreement form to the High Performance Operational Director by the due date. National squad athletes/teams are required to be familiar with the agreement, observe and abide by its terms throughout the squad year.

Your acceptance as a member of the 2008-2009 National Squad is conditional on you entering into this agreement and observing its terms.

You should carefully read this document so as to understand it and the consequences flowing from any breach of its terms.

Retain one copy of the Agreement as a reference copy and return a signed copy to the ISA High Performance Operational Director by **1 September 2008**

1. Introduction

This agreement covers the conditions by which I, the above athlete, have been selected as a member of the 2008 National Squad.

This agreement is not an employment agreement and does not make me an employee of ISA. I acknowledge that I am not required to provide any services to ISA.

I agree that my membership of the Team is conditional upon me entering into this agreement and observing its terms and conditions.

This agreement will commence when I have signed the agreement and upon receipt of the agreement by the ISA High Performance Operational Director and will conclude 31 July 2009.

2. Squad Requirements

As a member of the squad I agree to be bound by the following requirements. I agree that I will:

- a) Submit a copy of my Yearly Training Plan to the High Performance Operational Director by **30 September 2008**
- b) Submit quarterly reports (will be distributed one month prior to each due date) to the High Performance Operational Director as follows:
 - October –December by **12 December 2008**
 - January – March by **20 March 2009**
 - April – June by **19 June 2009**
- c) Participate in regular local monitoring sessions scheduled throughout the season by international judges/specialists assigned by the High Performance Operational Team
- d) Submit all required forms by the requisite deadlines. Such forms include, but are not limited to, Competition Entry Forms, Athlete Screening, Planned Program Content, Media Information, Nomination Forms, Whereabouts Notification Forms, and any other forms required by the Local Organising Committees
- e) Be familiar with and agree to abide by the ISA Anti-Doping Policy
- f) If notified by ASADA for being on the Registered Testing Pool (RTP), complete Athlete Whereabouts Notification forms for No Notice Out of Competition Drug Testing on a quarterly basis. Failure to complete the forms by the requisite deadlines may lead to a Doping Offence as detailed in ISA's Anti-Doping Regulations. Completion of Whereabouts Notification forms is a requirement of the World Anti Doping Agency, and the Australian Olympic Committee
- g) Conduct myself so as to obtain and maintain my best possible fitness and health as part of the National Squad to the best of my ability
- h) Undertake training in a responsible and enthusiastic manner
- i) Respect the spirit of fair play and non violence and behave accordingly on the sporting arena.

3. Financial Assistance

As a member of the squad I will qualify for financial assistance in a form of part-reimbursement of my training and/or competitions expenses. The amount of assistance will be based upon my final level as of 31 March 2009.

The assistance will be available to me in two instalments. Level C or D funding (as per Policy HPP-0807-V1) will be distributed in November 2008. Any balance of the amount of the final level of the athlete will be distributed by 31 March 2009.

I may qualify to receive additional performance based funding for international championship events as defined in the Competition Results Based ISA Funding.

No funding will be available to me if I do not enter into this National Squad Agreement or if I breach the squad requirements or any other part of this agreement.

4. Disclosure of Information

I permit my email addresses (as provided) to be included on the official ISA distribution lists and/or similar, for the purposes of disseminating information to national squad athletes.

5. Breach of this Agreement

I agree that, should I breach this agreement the ISA may at its discretion;

- a) terminate my membership of the squad
- b) terminate my funding
