# National Squad 2010-2011 Acceptance & Agreement

## Overview

This Acceptance and Agreement is for all athletes selected within the 2010-2011 National Squad. Athletes must complete and submit this National Squad Acceptance and Agreement form to the High Performance Operational Director by the due date to accept their 2010-2011 Squad membership. All athletes are required to be familiar with the agreement, observe and abide by its terms throughout the squad term.

## 1. Introduction

This agreement covers the conditions by which I, the above athlete, have been nominated as a member of the 2010-2011 National Squad.

I agree that my squad membership is conditional upon me entering into this agreement and observing its terms and conditions.

This agreement will commence when I have signed the agreement and upon receipt of the agreement by the ISA High Performance Operational Director and will conclude at the commencement of the 2011 Australian Figure Skating Championships.

## 2. Squad Requirements

As a member of the squad I agree to adhere to the following requirements. I agree that I will:

Planning, tracking and training

- a) Submit a copy of my Yearly Training Plan and goal milestones to the High Performance Operational Director by **28 January 2011**
- b) Submit quarterly reports tracking my progress to the High Performance Operational Director as follows:
  - January – March
  - April – June
  - July – September
  - October – December
- c) If within the ASAS tier, achieve the agreed goal milestones or provide justification for consideration to the High Performance Director
- d) Participate in compulsory ASAS Training Camps or have been granted a special circumstance by the High Performance Director if I'm an ASAS tier squad athlete.
- e) Participate in regular monitoring or tracking sessions scheduled throughout the season as assigned by the High Performance Director
- f) Notify the High Performance Director if injured and at least one month of training is affected or if I retire from the sport

Documents

- g) Submit all required forms by the requisite deadlines. Such forms include, but are not limited to; Competition Entry Forms, Training Plans, Training reports, Camp forms, Nomination Forms and Whereabouts Notification Forms

Anti-Doping

- h) Be familiar with and agree to abide by the ISA Anti-Doping Policy
- i) If notified by ASADA as included on the Registered Testing Pool (RTP), complete Athlete Whereabouts Notification forms for No Notice Out of Competition Drug Testing on a quarterly basis. Failure to complete the forms by the requisite deadlines may lead to a Doping Offence as detailed in ISA's Anti-Doping Regulations. Completion of Whereabouts Notification forms is a requirement of the World Anti Doping Agency, and the Australian Olympic Committee

Behaviour

- j) Conduct myself so as to obtain and maintain my best possible fitness and health as part of the National Squad to the best of my ability
- k) Undertake training in a responsible and enthusiastic manner
- l) Demonstrate athlete attitude and behaviour in training and during events or functions
- m) Conduct myself as a role model within Ice Skating Australia and to younger athletes
- n) Respect the spirit of fair play and non violence and behave accordingly on the sporting arena.

## 3. Financial Assistance

As an ASAS tiered squad member, I will qualify for financial assistance in a form of a training allowance. The amount of assistance will be based according to the National Squad Criteria & Funding (HPP-1007) and is dependent upon achieving the national squad requirements.

The squad funding will be available in two instalments. The initial 60% of squad funding (as per Policy HPP-0907-V1) will be distributed in February 2011. The final 40% squad balance will be distributed by 30 September 2011. No funding will be available to me if I do not enter into this National Squad Agreement or if I breach the squad requirements or any other part of this agreement.

As a member of the national squad (ASAS, B, Synchronized), I may qualify to receive additional performance based funding for international events as defined in the Athlete Results Based Funding (HPP-1011). Result based funding will be distributed in January and April 2011.

**4. Disclosure of Information**

I permit my email addresses (as provided) to be included on the official ISA distribution lists and/or similar, for the purposes of disseminating information to national squad athletes.

I consent to Ice Skating Australia forwarding my contact details (as provided) to ASADA to fulfil Anti-Doping requirements.

I consent to Ice Skating Australia or its stakeholders using photographs of me for the purposes of advertising, media publicity, publication, web display, general display or any other Association purposes in whole or in part. I waive any interest that I have in the copyright to the photograph(s) now or at any future time and state that I do not expect to receive any payment or consideration in respect of them.

**5. Breach of this Agreement**

I agree that, should I breach this agreement the ISA board or HP selection committee may at its discretion;

- a) terminate my funding and/or
- b) terminate my membership of the squad
