

## **SECTION 8**

### **INTERNATIONAL**

Amended May 2018

#### **By-Law 800**

1. A person representing Australia in an ISU World or World Junior Championship, an ISU Four Continents Championship or an International Competition must:
  - a) be an Australian citizen at the time of the commencement of the Australian Championship preceding the applicable ISU Championship or International Competition,OR
  - b) have been ordinarily resident in Australia for at least one year in accordance with ISU Rule 109 and complied with all the requirements of the ISU as detailed in ISU Regulations and applicable communications, including the obtaining of any necessary clearances from the National Association of the country of which the person is a citizen, and from the ISU, by the specified dates.
2. In the case of a pair or an ice dance couple, at least one partner must be an Australian citizen in accordance with ISA By-Law 800, paragraph 1a) and the other partner must comply with the provisions of ISU Rule 109 and applicable communications, including the obtaining of any necessary clearances from the National Association of the country of which that partner is a citizen, and from the ISU, by the specified dates.
3. A person representing Australia in any ISU Championship or international competition must have passed the requisite ISA qualifying test(s) prior to nomination.
4. In the case of a Synchronized Skating Team, ISU Rule 109.2(d) applies.

#### **By-Law 801**

#### **PERMISSION**

Prior permission must be gained by the Association to compete in any local or national competition conducted outside of Australia or in any competition in Australia that is not listed on the ISA or relevant State Association calendars.

#### **By-Law 802**

#### **ENTRIES**

1. Prior to any person seeking permission or nomination as an Australian competitor in any International event or competition held out of Australia, the person must be a financial member of a State Association.
2. Any person seeking permission or nomination to any International event or competition held outside of Australia shall have their Citizenship and/or residency, proof of age and membership status verified by their relevant State Association.
3. A request form shall be submitted to the members State Association that is forwarded to the Ice Skating Australia, for any person seeking nomination to any International competition.

#### **By-Law 803**

#### **SELECTION AND NOMINATIONS**

1. Selections and nominations of a person to any International Competition or ISU Championship shall be made by the Association in accordance with the Regulations of the ISU.
2. International Assignments and Championship selections will be determined by the Association in its absolute discretion after due consideration.

3. Nomination of a person to the Olympic Winter Games shall be made by the Association in accordance with the ISA Olympic Selection Policy, ISU Olympic Selection Rules and Communications and the Australian Olympic Committee policies.

**By-Law 804**

The appointment of officials and Judges to represent Australia at any International Competition or Championship shall be at the discretion of the Association.
